



## **-Barnacle Barrier™ Warranty-**

### **A. Warranty Terms**

- 1.) Barnacle Barrier™ warrants the bottom shield to be free from defects in materials and workmanship for a period of one (1) year from the date of original purchase.
- 2.) Barnacle Barrier™ warrants the air-gate components including air valves, hoses, and electrical components including the optional electric air-gate pump to be free from defects in material and workmanship under normal usage for a period of two (2) years from the date of original purchase.
- 3.) Barnacle Barrier™ Warranty applies only to the original purchaser and is non-transferable from one consumer to another.

### **B. Exclusions, Limitations and Conditions**

- 1.) This Warranty shall not apply to any Barnacle Barrier™ which has been damaged by accidents, negligence, misuse, abuse, improper operation, maintenance, storage, theft, fire, operation in an improper manor, alteration or tampering. This Warranty also shall not apply to damages caused by puncture, tearing, ripping, abrasion; algae or marine growth, and/or bottom shield becoming brittle, cracking or fading due to extreme environmental conditions. This Warranty shall not cover the normal cost of cleaning and maintenance.
- 2.) This Warranty shall not apply to normal servicing and maintenance procedures.

### **C. Warranty Repair Procedure**

- 1.) If a defect arises during the Warranty period, you must ship the defective part and proof of purchase (receipt) to Barnacle Barrier™; **265 South Federal Highway, unit 179, Deerfield Beach Florida, 33441** for inspection within thirty (30) days of occurrence of defect. It is the responsibility of the customer to return the part prepaid to Barnacle Barrier™ for product evaluation.

### **D. Other Important Information**

- 1.) THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER EXPRESS WARRANTIES, IMPLIED WARRANTIES, INCLUDED BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, SHALL NOT EXTEND BEYOND THE DURATION OF THE EXPRESS WARRANTIES PROVIDED HEREIN. BARNACLE BARRIER™ SOLE OBLIGATION AND YOUR EXCLUSIVE REMEDY UNDER THIS WARRANTY IS LIMITED TO REPAIR IN ACCORDANCE WITH WARRANTY. BARNACLE BARRIER™ SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, OR CONTINGENT DAMAGES OR ANTICIPATED OR LOST PROFITS WHATSOEVER.
